This contract is terminable at will by the Great Bend Renaissance Fair for violations of these rules and policies. Any violation of these rules and policies will result in forfeiture of all contract monies agreed to.

The performer(s) agrees to allow the Great Bend Renaissance Fair and its associates to use photos, video, and performer's individual likeness for advertising purposes of the Festival.

The undersigned agrees to indemnify The Great Bend Renaissance Fair, its owners and managers, and hold the aforementioned parties harmless from any liability whatsoever from claim; including but not limited to bodily injury, property damage, fire, theft, explosion, or any loss sustained by the undersigned or any of the undersigned's group while contracted with the Great Bend Renaissance Fair.

It is agreed that the above contractor is an independent contractor and as such is responsible for all and any taxes, including workman's compensation.

We are looking for alternative sleeping arrangements for our performers this year. Specifically, we are planning on renting furnished houses on the weekend of the faire. We will do our best to make sure privacy of performers is respected in these arrangements and that comfort is assured.
