4. Please include your state sales tax number. (If you do more than two shows a year in Kansas you are required to have your own sales tax number.)

All application fees will be deposited upon receipt. If your application is refused, your fee will be returned and you may resubmit. The only reasons any application will be refused would be:

- A: Merchandise isn't appropriate for renaissance period
- B: Too many vendors with similar merchandise
- C: Merchandise deemed inappropriate for any other reason.

We expect every booth that is actually selling some kind of product to craft some of their products. Many booths sell some manufactured goods and we will tolerate this as long as some items are home made. We do not want to be a "Ren Mart" fair. Vendors must wear renaissance appropriate clothing.

Vendor space: Standard 15x15	\$50 until April 15th 2011
	\$75 after April 15th 2011
Food Vendors: Standard 15 X15	\$75 until April 15th 2011
	\$100 after April 15th 2011

Extra Needed Space will be allotted in 5X15 increments @ \$10 per increment so that a 15X20 would cost \$60 and 15X25 would cost \$70 etc. If you are unsure contact me by email at pastordave@cox.net and we'll work out costs.

Please include space for your tie-downs and ropes and customer walk space when figuring extra sq footage.

Deadline for merchants is April 15th 2011.

Standard spaces are \$50 until April 15th, 2011. After this date, it will be \$75 depending on approval and available space.

There will be a fee added for checks returned for insufficient funds.

All federal, state, and local laws governing retail sales tax must be followed. You are responsible for all federal, state, and local taxes. State tax is now 7.3%. You must understand the rules and regulations of the show and must comply. Failure to comply may result in expulsion from the show.
